Weather conditions, lightning/thunder and wind, wildlife, creeks/ponds, variations in terrain man-made or natural.
- To surface and subsurface areas such as uneven terrain, sink holes, turtle, mole and gopher holes as well as overhead hazards such as low lying branches and falling moss and limbs.

- The potential collision with other animals or objects such as mechanical gates, fencing, electric hot wire, trailers, wheel barrels and manure racks, golf carts, lawn mowers, gazebo, hammocks, picnic tables, BBQ's, fire pit rings, and sundry camping items.
- The possibility of another individual's negligent behavior that may contribute to injury of themselves or others as well as their respective animals.
- The risk of exposure to fire pits, cooking grills/BBQ and possibly handling firearms for those who have a concealed weapons license.
- All minors must be accompanied by a parent, guardian or custodian and must sign above and agree to the same terms of this waiver on behalf of said minor.
